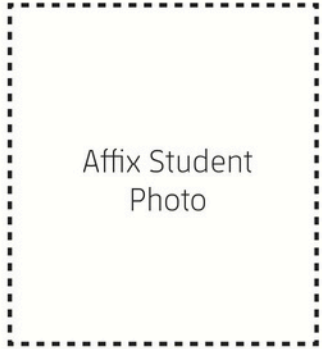

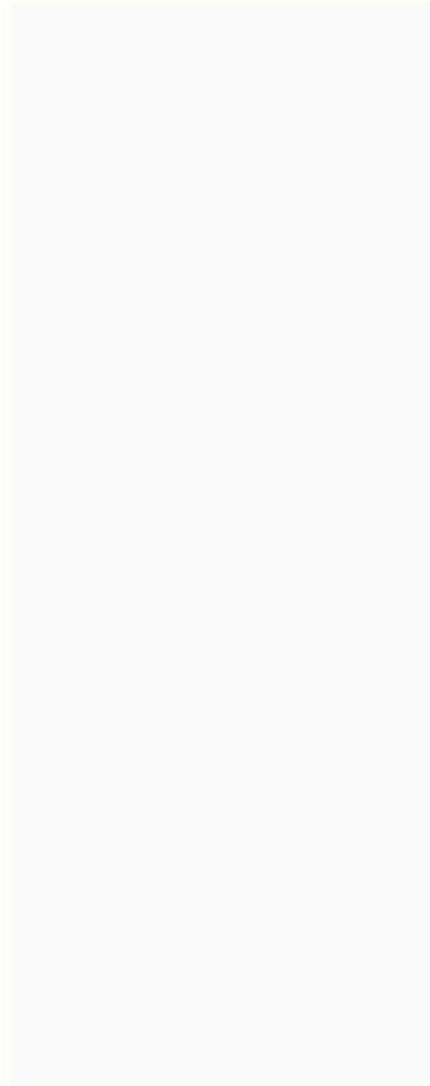

Terms and Conditions

Please read the following terms and conditions carefully before registering, using or obtaining any materials, information, products or services. By signing below, you agree to be bound by these terms and conditions. If you do not accept all of these Terms, then you may not register your child at the Athletico Lusaka Academy.

In these Terms, "we", "us", "our", or "academy" and/or "Athletico Lusaka" refers to the Athletico Lusaka Academy, and "you" or "your" refers to you as the parent/guardian of the registering child.

*A soft/hardcopy of our Terms and Conditions may be provided upon request.

1.0 General

The Athletico Lusaka Academy is a comprehensive football training program for boys and girls between the ages of 6-14 years of age. Training sessions are conducted every Monday, Wednesday and Friday between 15:30 to 16:45hrs. In order for a child to be registered, only the child's parent/guardian must complete, sign and submit both registration and Terms and Conditions form to our offices.

The Athletico Lusaka Academy reserves the right to refuse registrations.

1.1 Payment and Fees

At Athletico Lusaka the payment of subscription, and all other applicable fees, becomes an obligation at the time of registration. Before registration is considered valid, the Academy has the right to require a student to pay any prior obligations due on his/her account and make the payment required for the current month/season.

Prior to each month a requested Advanced Billing Statement for the upcoming month will be sent out itemising payment obligations to the Academy including, but not limited too, subscription fees, any balance occurred and exchange rate differences.

If full payments of the upcoming monthly subscription fee, as well as any other applicable academy charges/fees, are not paid before the 5th of that month the account will be considered delinquent.

1.2 Delinquent Accounts

A student's account becomes delinquent because payments are not made to the Academy according to the terms above. If payments are not made by the Academy's due dates the entire balance shall be immediately due and payable and the Academy has the right to take steps to collect the balance including, but not limited to, the following; excluding the students from training; turning the student's account over to a collection agency; and taking legal action to collect the balance due. By signing below, the parent/guardian authorises the Academy to release financial information about his/her account and other information useful in verifying the charges on the account to those concerned with collecting the balance owing.

This payment agreement will cover the student's obligations to the Academy for as long as the student continues to incur obligations to the Academy and/or has an outstanding balance on his/her account.

1.3 Exchange Rate

All payments to Athletico Lusaka shall be made in United States dollars (US\$) or Zambian Kwacha (ZMW) equivalent according to the prevailing commercial bank selling exchange rate of that particular day. The exchange rate used is in accordance with the conversion rates published by Global Markets Zambia for Stanbic Bank.





2.0 Suspension and Termination of Services

By Parent/Guardian. You may terminate your Subscription at any time through e-mailing info@atleticolusaka.com or by submitting an official hard copy letter to the registration officer stating so. Such termination will result in your child not being able to attend any training/games held by the Athletico Lusaka Academy. Terminations are confirmed immediately and you will not be charged again for that Subscription unless you register for a new month. If you terminate a Subscription in the middle of a billing cycle, you will not receive a refund for any period of time you did not use in that cycle unless you are terminating for any of the following reasons: (a) we have materially breached these Terms and failed to cure that breach within 30 days after you have so notified us in writing; or (b) a refund is required by law.

2.1 By Athletico Lusaka Academy

Athletico Lusaka Academy may limit/suspend/terminate a child's subscription for any, but not limited to, reasons; (a) you fail to pay fees by the due date (b) your child has engaged in inappropriate conduct; (c) you have materially breached these Terms and failed to cure the breach within 30 days after Athletico Lusaka Academy has so notified you in writing.

3.0 Photo & Video

By registering you release image/video rights and accept and acknowledge that pictures and/or videos of your child may be posted on any social media sites operated by Athletico Lusaka Academy. The Athletico Lusaka Academy upholds high standards for all social media and photo/video materials.

4.0 Late Pick-Up

All children MUST be collected immediately after their training sessions are done. If for any reason a parent/guardian is unable to collect child on time, we ask that you call Administration (+260 973 634 340) as soon as possible. You will be charged a late pick-up fee of K100. If we have no contact from a parent/guardian by 17.00hrs of that day, we will contact Social Welfare to advise them we have an uncollected child. We reserve the right to refuse future subscription from parents who continuously pick children up late.

5.0 Medical Consent

By registering you do hereby ensure that your child is deemed physically fit to participate in any of the sporting activities conducted at the Athletico Lusaka Academy and confirm that the said child has no known physical/mental impairment preventing him/her from participating in the academy's program. By signing below you do hereby consent for your child to be given emergency treatment at a local hospital if deemed necessary by the on-site medical staffing and do hereby agree to any medical care determined by a physician to be necessary for the welfare of your child while said child is under the care of the Athletico Lusaka Academy when you are not reasonably available by telephone to give consent.

6.0 Release Statements

By signing below you do hereby agree to take full responsibility for any risks or loss, property damage, or personal injury (including death), that may be sustained by said child, or loss or damage to property owned by said child, as a result of participation in the academy's training sessions, leagues or any other activity conducted while on or upon the premises where the event is being conducted.

I do hereby indemnify and release, waiver, discharge, the property owners Lusaka City Council, Futsal & Sports Complex, Athletico Lusaka Academy, servants, agents and employees from any and all liability, claims, demands, actions and causes of action whatsoever arising of or related to any loss, damage, or injury, including death, that may be sustained to the above mentioned child or to any such child's property, while participating in any of the activities while on or upon the premises where the child is training or participating including any and all tournaments conducted by Athletico Lusaka Academy whether in Lusaka, Zambia or any international destination.
